Déanfaidh BIÉ, i bhfeidhmiú na gcumhachtaí a thugtar dó le hAlt 37 den Acht Iompair (Bonneagar Iarnróid) 2001 (arna leasú) (an “tAcht”), iarratas ar an Luan, an 18 Samhain 2024 nó dá éis, chuig an mBord Pleanála le haghaidh Ordú Iarnróid (Luas - Fionnghlas – Droichead Broome go Baile Shéarlais) [2024] de bhun fhorálacha an Achta.

**Ordú Iarnróid Beartaithe**

Údaróidh an tOrdú Iarnróid, má dheonaítear é, do BIÉ na hoibreacha iarnróid a dhéanamh mar atá leagtha amach san Ordú Iarnróid, lena n-áirítear na hoibreacha go léir is gá chun go bhféadfar iarnród atá ainmnithe mar iarnród éadrom a thógáil, a oibriú, a chothabháil agus a fheabhsú, lena n-áirítear, inter alia, síneadh ó thuaidh den Líne Uaine Luas a thógáil, thart ar 3.9km ar fad, óna stáisiún ceann aistir reatha i nDroichead Broome go stáisiún ceann aistir nua i mBaile Shéarlais, in aice leis an acomhal N2-M50, le 4 stad nua, struchtúir droichid, áiseanna agus bonneagar rothaíochta, áis pháirceáil agus taistil nua amháin agus síneadh nua chuig saoráidí stáblaíochta iosta Dhroichead Broome. De bhun alt 43(5) den Acht, féadfaidh BIÉ, le toiliú an Aire Iompair, socrúithe a dhéanamh le duine eile chun an t-iarnród nó na hoibreacha iarnróid lena mbaineann an t-ordú a dhéanamh, a chothabháil, a fheabhsú nó a oibriú.

Is éard a bheidh sna hoibreacha iarnróid atá beartaithe mar atá leagtha amach san Ordú Iarnróid go ginearálta, gan a bheith teoranta don mhéid céanna, ná Iarnród thart ar 3.9 ciliméadar ar fad a ritheann ó stáisiún ceann aistir na Líne Uaine atá ann cheana féin ag Droichead Broome go dtí stáisiún ceann aistir nua ag Baile Shéarlais a thógáil, lena n-áirítear áiseanna agus bonneagar rothaíochta. Trasnóidh an t-aillíniú ráille thar líne reatha Iarnród Éireann Má Nuad agus an Chanáil Ríoga trí struchtúr droichid, leanfaidh sé ar aghaidh feadh Bhóthar Dhroichead Broome, trasnóidh sé an Tulcha trí struchtúr droichid eile agus leanfaidh sé ar aghaidh trí Pháirc Ghleann na Tulchann. Rachaidh an t-aillíniú trasna Bhóthar Ghleann na Tulchann agus leanfaidh sé ar aghaidh feadh iar-Ghleann Shruith Choill Fhionnghlaise le teacht chomh fada le stad San Eiléana sula dtrasnóidh sé chuig páirceanna Fhearnáin a mhodhnófar chun freastal ar an scéim. Leanfaidh an líne ar aghaidh tríd an bpáirc agus trasnóidh sí Bóthar Chnocán an Tobair isteach i bPlás Thobar Phádraig, áit a ndéanfar an bóthar rochtana atá ann faoi láthair a athrú. Sínfidh an t-aillíniú ar aghaidh idir forbairt reatha Chúirt na bhFiach agus Stáisiún Gardaí Fhionnghlaise chun teacht chomh fada le stad Shráidbhaille Fhionnghlaise. Beidh an líne á rith ansin comhthreomhar leis an mbóthar N2 sula dtrasnóidh sí an timpeallán atá ann cheana a gcuirfead acomhal comharthaithe comhréidh ina ionad. Tógfar struchtúr ilstórách páirceála agus taistil sa cheantar seo. Casfar an t-aillíniú ansin ar Bhóthar San Maighréad áit a mbeidh stad San Maighréad suite. Leanfaidh an bealach ar aghaidh ó thuaidh sula sroichfidh sé stáisiún ceann aistir Bhaile Shéarlais, áit a ndéanfar an t-acomhal atá ann le Bóthar Uí Mhaoilmhichíl a athchumrú.

Cuimseoidh na hoibreacha iarnróid atá beartaithe mar atá leagtha amach san Ordú Iarnróid agus comharthaíocht iarnróid, córais cheannais agus rialaithe agus cumarsáide; soláthar áiseanna agus bonneagar rothaíochta, soláthar fostáisiúin leictreachais; compúin shealadacha tógála a bhunú; bainistíocht tráchta shealadach agus atreoruithe bóthair a bhunú; bealaí rochtana nua agus athailínithe agus feabhsuithe ar acomhail bhóithre; atreorú ar na fóntais atá ann cheana féin; bonneagar nua draenála a sholáthar; bearta maolaithe comhshaoil a sholáthar; agus mionathruithe bonneagair eile chun an tionscadal foriomlán a éascú.

Áirítear freisin leis an Ordú Iarnróid, má dheonaítear é, cumhachtaí do BIÉ talamh nó cearta a fháil go héigeantach i dtalamh, faoi thalamh nó thar thalamh, nó in aon aerspás, a shonraítear san ordú; talamh, nó aon aerspás, a shonraítear san ordú a fháil agus a áitiú go sealadach; éasúintí agus cearta eile a fháil thar thalamh a shonraítear san ordú (lena n-áirítear cearta atá ann nó a údaráítear do BIÉ a chruthú); cearta poiblí, lena n-áirítear cearta slí poiblí a shonraítear san ordú a chealú; agus déantar foráil ann maidir le cearta eile thar thalamh.

Tá na hoibreacha iarnróid atá beartaithe mar atá leagtha amach san Ordú Iarnróid faoi réir Measúnachta Tionchair Timpeallachta agus Measúnachta Cuí agus maidir leis sin tá Tuarascáil Measúnachta Tionchair Timpeallachta, Tuarascáil Scagtha ar Mheasúnacht Chúí, agus Ráiteas Tionchair Natura á gcúir isteach leis an iarratas.

**AN BORD PLEANÁLA**  
**TRANSPORT (RAILWAY INFRASTRUCTURE) ACT 2001**  
**(AS AMENDED)**

**Application by the National Roads Authority**  
**(operating as Transport Infrastructure Ireland) (“TII”)**  
**for the Railway (Luas Finglas – Broombridge to Charlestown)**  
**Order [2024].**

TII, in exercise of the powers conferred upon it by Section 37 of the Transport (Railway Infrastructure) Act 2001 (as amended) (the “Act”), will apply on or after Monday 18th November 2024 to An Bord Pleanála for a Railway (Luas Finglas – Broombridge to Charlestown) Order [2024] pursuant to the provisions of the Act.

**Proposed Railway Order**

The Railway Order, if granted, will authorise TII to carry out the railway works as set out in the Railway Order including all works necessary to enable the construction, operation, maintenance and improvement of a railway designated as a light railway including, inter alia, the construction of a northern extension of the Luas Green Line, approximately 3.9km long, from its current terminus in Broombridge to a new terminus in Charlestown, in close proximity to the N2-M50 interchange, with 4 new stops, bridge structures, cycling facilities and infrastructure, one new park and ride and a new extension to Broombridge depot stabling facilities. Pursuant to section 43(5) of the Act, TII may, with the consent of the Minister for Transport, make arrangements with another person to construct, maintain, improve or operate the railway or the railway works to which the order relates.

The proposed railway works as set out in the Railway Order will generally comprise but are not limited to the construction of a Railway approximately 3.9 kilometres in length running from the existing Green Line terminus at Broombridge to a new terminus at Charlestown including cycling facilities and infrastructure. The track alignment will cross over the existing Iarnród Éireann Maynooth line and Royal Canal via a bridge structure, continue along Broombridge Road, cross the Tolka River via another bridge structure and continue through Tolka Valley Park. The alignment will cross Tolka Valley Road and continue along the former Finglaswood Stream Valley to arrive at St Helena’s stop before crossing to Farnham pitches which will be modified to accommodate the scheme. The line will continue through the park and cross Wellmount Road into Patrickswell Place, where the existing access road will be realigned. The alignment will proceed between the existing Ravens Court development and Finglas Garda Station to arrive at Finglas Village stop. The line will then run parallel to the N2 road before crossing the existing roundabout which will be replaced with an at grade signalised junction. A multi-storey park and ride structure will be constructed in this area. The alignment will then turn onto St Margaret’s Road where the St Margaret’s stop will be located. The route will continue northwards before arriving at the Charlestown terminus where the existing junction with Melville Road will be reconfigured.

The proposed railway works as set out in the Railway Order will also include railway signalling, command and control and communications systems; provision of cycling facilities and infrastructure, provision of electrical substations; establishment of temporary construction compounds; establishment of temporary traffic management and road diversions; new and realigned access routes and road junction improvements; diversion of existing utilities; provision of new drainage infrastructure; provision of environmental mitigation measures; and other infrastructural modifications to facilitate the overall project.

The Railway Order, if granted, also includes powers for TII to acquire compulsorily land or rights in, under or over land, or any airspace, specified in the order; to temporarily acquire and occupy land, or any airspace, specified in the order; to acquire easements and other rights over land specified in the order (including rights which exist or which TII is authorised to create); to extinguish public rights including public rights of way specified in the order; and provides for other rights over land.

The proposed railway works as set out in the Railway Order are subject to an Environmental Impact Assessment and an Appropriate Assessment and in that regard an Environmental Impact Assessment Report, an Appropriate Assessment Screening Report, and a Natura Impact Statement are being submitted with the application.

**Types of decisions that may be made by An Bord Pleanála**

In accordance with section 43(2) of the Act, An Bord Pleanála:-

- (a) if it is of opinion that the application should be granted, shall make the Railway Order, subject to such conditions, modifications, restrictions and requirements (and on such other terms) as the Board thinks proper and specifies in the order, or
- (b) if it is of opinion that the application should not be granted, refuse to make the Railway Order.

The Railway Order application will include the following documentation:

1. A draft of the proposed Railway Order, entitled “Railway (Luas Finglas – Broombridge to Charlestown) Order [2024]”;
2. A plan of the proposed railway works;
3. A book of reference to the plan of the proposed railway works (indicating the identity of the owners and of the occupiers of the lands described in the plan);
4. An Environmental Impact Assessment Report assessing the likely significant effects on the environment of the proposed railway works; and
5. An Appropriate Assessment Screening Report and Natura Impact Statement.

**AN BORD PLEANÁLA**

**Application by the National Roads Authority**  
**(operating as Transport Infrastructure Ireland) ("TII")**  
**for the Railway (Luas Finglas – Broombridge to Charlestown)**  
**Order [2024].**

TII, in exercise of the powers conferred upon it by Section 37 of the Transport (Railway Infrastructure) Act 2001 (as amended) (the "Act"), will apply on or after Monday 18th November 2024 to An Bord Pleanála for a Railway (Luas Finglas – Broombridge to Charlestown) Order [2024] pursuant to the provisions of the Act.

**Proposed Railway Order**

The Railway Order, if granted, will authorise TII to carry out the railway works as set out in the Railway Order including all works necessary to enable the construction, operation, maintenance and improvement of a railway designated as a light railway including, inter alia, the construction of a northern extension of the Luas Green Line, approximately 3.9km long, from its current terminus in Broombridge to a new terminus in Charlestown, in close proximity to the N2-M50 interchange, with 4 new stops, bridge structures, cycling facilities and infrastructure, one new park and ride and a new extension to Broombridge depot stabling facilities. Pursuant to section 43(5) of the Act, TII may, with the consent of the Minister for Transport, make arrangements with another person to construct, maintain, improve or operate the railway or the railway works to which the order relates.

The proposed railway works as set out in the Railway Order will generally comprise but are not limited to the construction of a Railway approximately 3.9 kilometres in length running from the existing Green Line terminus at Broombridge to a new terminus at Charlestown including cycling facilities and infrastructure. The track alignment will cross over the existing Iarnród Éireann Maynooth line and Royal Canal via a bridge structure, continue along Broombridge Road, cross the Tolka River via another bridge structure and continue through Tolka Valley Park. The alignment will cross Tolka Valley Road and continue along the former Finglaswood Stream Valley to arrive at St Helena's stop before crossing to Farnham pitches which will be modified to accommodate the scheme. The line will continue through the park and cross Wellmount Road into Patrickswell Place, where the existing access road will be realigned. The alignment will proceed between the existing Ravens Court development and Finglas Garda Station to arrive at Finglas Village stop. The line will then run parallel to the N2 road before crossing the existing roundabout which will be replaced with an at grade signalised junction. A multi-storey park and ride structure will be constructed in this area. The alignment will then turn onto St Margaret's Road where the St Margaret's stop will be located. The route will continue northwards before arriving at the Charlestown terminus where the existing junction with Melville Road will be reconfigured.

The proposed railway works as set out in the Railway Order will also include railway signalling, command and control and communications systems; provision of cycling facilities and infrastructure, provision of electrical substations; establishment of temporary construction compounds; establishment of temporary traffic management and road diversions; new and realigned access routes and road junction improvements; diversion of existing utilities; provision of new drainage infrastructure; provision of environmental mitigation measures; and other infrastructural modifications to facilitate the overall project.

The Railway Order, if granted, also includes powers for TII to acquire compulsorily land or rights in, under or over land, or any airspace, specified in the order; to temporarily acquire and occupy land, or any airspace, specified in the order; to acquire easements and other rights over land specified in the order (including rights which exist or which TII is authorised to create); to extinguish public rights including public rights of way specified in the order; and provides for other rights over land.

The proposed railway works as set out in the Railway Order are subject to an Environmental Impact Assessment and an Appropriate Assessment and in that regard an Environmental Impact Assessment Report, an Appropriate Assessment Screening Report, and a Natura Impact Statement are being submitted with the application.

**Types of decisions that may be made by An Bord Pleanála**

In accordance with section 43(2) of the Act, An Bord Pleanála:-

- if it is of opinion that the application should be granted, shall make the Railway Order, subject to such conditions, modifications, restrictions and requirements (and on such other terms) as the Board thinks proper and specifies in the order, or
- if it is of opinion that the application should not be granted, refuse to make the Railway Order.

**The Railway Order application will include the following documentation:**

- A draft of the proposed Railway Order, entitled "Railway (Luas Finglas – Broombridge to Charlestown) Order [2024]";
- A plan of the proposed railway works;
- A book of reference to the plan of the proposed railway works (indicating the identity of the owners and of the occupiers of the lands described in the plan);
- An Environmental Impact Assessment Report assessing the likely significant effects on the environment of the proposed railway works; and
- An Appropriate Assessment Screening Report and Natura Impact Statement.
